**IN CONSIDERATION** of being permitted to participate in any way in Laramie Racing, LLC sponsored Bicycling and other Outdoor Activities ("Activities" or "Activity") I for myself, my personal representatives, assigns, Heirs and next of kin:

1. **ACKNOWLEDGE**, agree, and represent that I understand the nature of the Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity and the equipment I will use is in proper working condition. I acknowledge that I am voluntarily participating in the Activity with knowledge of the potential hazards involved and accept all risks of injury, inconvenience, harm, loss or death. I acknowledge that I am solely responsible for my personal health and safety, and the personal property I use during the Activity. I further acknowledge that the Activity will be conducted over public roads and trails and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. I agree to abide by the rules and regulations established by Laramie Racing, LLC, applicable traffic laws, and any other applicable laws, and conduct myself in a safe and prudent manner while participating in the Activity. I further agree and warrant that if at any time I believe conditions to be unsafe I will immediately discontinue further participation in the Activity.
2. **FULLY UNDERSTAND** that: (a) the Activities involve risk and dangers of serious bodily injury, including permanent disability paralysis and death ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the "Releasees" named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and all responsibility for losses, costs and damages I incur as a result of my participation in the Activity.
3. **HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS** Laramie Racing, LLC, their respective administrators, officers, directors, agents and employees, successors and assigns, and other participants, sponsors, advertisers, and if applicable, owners, lessors, or leasees of premises on which the Activity takes place ("Releasees" herein) from all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue actions, and litigation expenses, attorney fees, loss liability, damage or cost any may incur as the result of any claim.
4. **I HAVE READ THIS AGREEMENT**, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature. It is intended it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
5. **CONSENT** to and authorize in advance the use of any photographs, pictures, likeness, film or videotape taken of me or provided by me for publicity, promotion, television, websites or any other use, and expressly waive any right of privacy, compensation, copyright or other ownership right connected to same.
